After sending it, it is entrants’ responsibility to confirm receipt of email via phone with Holiday Harbor Marina and provide a payment over the phone to Holiday Harbor Marina (850) 492-0555. Registration will continue through July 28, but any registrations received after the start of the tournament cannot weigh a fish until 48 hours after registration. Registration closes at the end of business July 28.

If you pay with cash, you will need to do so in-person at the Marina.
